New Business, Agenda Item 1, "MDOT Contract 2018-0866"- The airport recently received Federal Grant 3-26-0041-4318 for \$429,395.00. The purpose of the grant is to conduct an approach survey, acquire land on the end of runway 25, remove obstructions, and update the Airport Layout Plan. The state will also contribute 2.5% or \$11,300.00 along with the Counties local share of \$11,300.00 to make the total grant amount \$451,995.00. The state requires a contract between Houghton County and the state for their share of the grant. The Airport Manager requested approval of MDOT contract 2018-0866 and authorization to have the Airport Committee Chairman sign the agreement.

New Business, Agenda Item 3, "Century 21 North Country Realtor Contract Amendment-Industrial Park"- The Airport Manager requested a motion to approve the Century 21 contract amendments for 9 lots in the Industrial Park. The amendments extend the term until 10/31/2019.

New Business, Agenda Item 4, "Mead & Hunt Contract- Design Rwy 13/31 and Twy C Rehabilitation"- The design contract is for field site investigation, design engineering, and construction plan and specification preparation for the rehabilitation of Runway 13/31 and Taxiway C. Rehabilitation is necessary due to the age and condition of the runway and taxiway per FAA standards. The FAA has applied for Discretionary funding and anticipates construction to begin in 2020. To meet the FAA's time frame, design will need to be completed by the spring of 2019 so the project can be let in the Fall of 2019. The County will have to fund the design and get reimbursed sometime after September with the 2019 grant. Total amount of this contract is \$352,550. The Airport Manager requested a motion to have the Airport Committee approve the contract.

**New Business, Agenda Item 5, "Mead & Hunt Monthly Progress Report"-** The Mead & Hunt progress report summarizing activities for the time period of September 1, 2018 through September 30, 2018 was presented for review.

**New Business, Agenda Item 4, "Water/Sewer Report**"- For the period from August 15, 2018 to September 18, 2018 (34 days) daily I&I was 6,823 gallons. For the same time period in 2017 I&I was 8,393 gallons. For the period from August 15, 2018 to September 18, 2018 (34 days) water loss was 111,264 gallons. For the same time period in 2017 water loss was 38,284 gallons.
