**New Business, Agenda Item 3, "Airport Meeting Committee dates for 2025"** – The Airport Manager requested a motion to approve the list of 2025 Airport Committee Meeting dates for 2025.

A motion was made by Glenn Anderson to approve the request, second by Tom Tikkanen.

**New Business, Agenda Item 4, "DOT EAS Selection Order"** – On December 13, 2024 the DOT issued order DOT-OST-2009-0302 selecting SkyWest Inc. branded under United Express to provide Essential Air Service (EAS) at Houghton for a 3 year period from February 1, 2025 through January 31, 2028.

**New Business, Agenda Item 5, "Mead & Hunt Monthly Progress Report"**. – The Airport Manager reviewed the Mead & Hunt progress report summarizing activities for the period from November 1, 2024 through November 30, 2024.

**New Business Agenda Item 6, "Water/Sewage Report."** – The Airport Manager reviewed the Water & Sewer report for the period from November 14, 2024 to December 13, 2024 (29 days). The daily I&I was 7,217 gallons. For the same time period in 2023, I&I was 5,672 gallons. For the period from November 14, 2024, to December 13,, 2024 (29 days) water loss was (138,993) gallons. For the same time period in 2023 water loss was (143,492) gallons.

**New Business Agenda Item 7, "Airline Monthly Statistics."** – The Airport Manager reviewed the Airline Statistics for the month of November 2024; SkyWest enplaned 2,063 passengers and deplaned 1,985. Last year in November SkyWest enplanements were 1,850 compared to this year's enplanements of 2,063 an increase of 213 passengers or 12%. SkyWest experienced 1 cancellation during the month compared to 1 in November of 2023. Our completed flights load factor was 69% compared to 63% in 2023.

**ADJOURNMENT:** A motion was made by Glenn Anderson to adjourn the meeting at 1:47 PM, seconded by Tom Tikkanen.


